PUBLIC HEARING: Draft Highway 9/ San Lorenzo Valley Complete Streets Corridor Plan

The RTC held a public hearing and received input on the [draft Highway 9/San Lorenzo Valley Complete Streets Corridor Plan](#). The draft plan identifies, evaluates, and prioritizes transportation concepts that provide safety, access to schools, businesses, bus stops, and traffic operations. Comments received by February 15, 2019 via an [online survey](#) or sent to slvplan@sccrtc.org will be considered during development of the final plan.

2019 State and Federal Legislative Programs

The RTC approved the State and Federal Legislative Programs to guide analysis of state and federal legislative or administrative actions that could impact transportation projects in Santa Cruz County. The legislative priorities recommended for 2019 focus on transportation funding, safety and speed limits, and project implementation.
