14. E&D TAC Committee Report 2012-2015

Grace Blakeslee, RTC Transportation Planner, requested members provide input on the draft report, direct RTC staff to present the final Committee Report 2012-2015 to the RTC and, recommend locations for distributing the Committee Report 2012-2015. Committee members recommend additions to the Committee Report to reflect tasks completed by the Pedestrian Safety Work Group, the E&D TAC review of Transportation Development Act Claims, and to include links to documents developed by the Pedestrian Safety Work Group. Committee Members recommended distributing the report to libraries and the Community Safety Traffic Coalition.

15. Review 2016 Preliminary Draft Unmet Needs

Grace Blakeslee, RTC Transportation Planner, discussed the Preliminary Draft 2016 Unmet Paratransit and Transit Needs list and schedule for development and approval of the final 2016 Unmet Paratransit and Transit Needs list. Ms. Blakeslee reported that a comprehensive update of the Unmet Paratransit and Transit Needs list was completed in 2015. Mr. Kemp requested that a need for free and low cost paratransit and transit rides be listed as an unmet need.

16. Transportation Expenditure Plan – Mobility Access Funding Category

Grace Blakeslee, RTC Transportation Planner provided information about the November 2016 Transportation Investment Plan – Mobility Access Category of the ballot measure.

Members discussed the:

- intent of the Mobility Access Category
- voter support for transportation solutions for seniors, disabled individuals, and veterans
- Santa Cruz Metro Board of Directors action regarding expenditure of the potential new funding source
- transportation services provided by ParaCruz and Lift Line to seniors and people living with disabilities
- alternative allocations of funding to Santa Cruz Metro and Lift Line
- role of paratransit and transit services working together to meet the transportation needs of seniors and disabled individuals
- possibility of Santa Cruz Metro addressing structural deficit by reducing service for fixed route and ParaCruz services
- obligation to the community to be clear about the use of any new funding sources and delivery of expected transportation services
- funding for improvements to the highway corridor and other transportation needs
- endorsements and stipulations for the Investment Plan received from Capitola City Council and various other entities
- timing of information for the ballot measure provided to E&D TAC
- calling a special meeting of the E&D TAC if new information about the ballot measure needs to be relayed to the E&D TAC

17. Santa Cruz Metro Title VI Program Report

Leslyn Syren, Santa Cruz Metro Legal Counsel, provided an update on the Santa Cruz Metro Title VI Program. Metro is considering modification to the Title VI Regulation and Title VI Program Report. The Title VI Program Report is on Santa Cruz Metro's website and available for public inspection at Metro's Administrative Offices, 110 Vernon Street from 8:00 am to 5:00 pm, Mon.-Fri. through March 25, 2016. Metro's Board of Directors will consider adoption of the proposed Title VI Programs Report at the Public Hearing on March 25, 2016.

18. Transit Planning for All Grant Application

Grace Blakeslee, RTC Transportation Planner discussed the Transit Planning for All: Inclusive Planning Impact Grant and requested that the E&D TAC provide input on outreach to seniors and people living with disabilities in rural areas of Santa Cruz County.

19. Pedestrian Safety Work Group Update

Veronica Elsea, Pedestrian Safety Work Group Chair, informed members that the Committee continues its work on the brochure, 'What Pedestrians and Bicyclists Want Each Other to Know'. Ms. Elsea mentioned that she experienced difficulty using the online pedestrian hazard "Pin Drop" feature. The next meeting of the Pedestrian Safety Work Group is February 16, 1:30 pm to 3:00 pm in the RTC conference room.

20. 2016 E&D TAC Meeting Schedule

Grace Blakeslee, RTC Transportation Planner, discussed the E&D TAC 2016 Meeting Schedule and meeting topics. The 2016 Meeting Schedule identifies a September 6, 2016 meeting and canceling the regular August 9, 2016 meeting. Ms. Elsea requested the addition of a May 10, 2016 meeting to discuss Santa Cruz Metro's proposed changes to transit service. Ms Elsea also requested the option of a special meeting prior to the regularly scheduled April 12, 2016 meeting if new information about the Transportation Investment Plan is available. Mr. Kemp requested that the RTC Legislative Program be added to the list of meeting topics.

Action: The motion (Lamb/Kempf) - - to approve the 2016 E&D TAC calendar, to schedule a special May 2016 meeting of the E&D TAC, request that Santa Cruz Metro come to present proposed transit service changes on May 10, 2016 at public meeting of the E&D TAC, and maintain the option to schedule a special meeting, if needed, prior to the April 12, 2016 meeting- - carries.
