# **REGULAR AGENDA**

# 22. Commissioner reports

Commissioner Alternate Hurst delivered comments on the recent meeting of the Vision Zero team and efforts to improve safety in the Pajaro Valley.

Commissioner Bertrand reported on issues discussed during the recent Coast Rail Coordinating Council (CRCC) meetings, particularly focused on commuter traffic on the San Francisco Bay side of the peninsula and extending infrastructure potentially through Salinas.

Chair Brown reported on the electric bicycle incentive programs offered by Central Coast Community Energy and the Monterey Bay Air Resources District. Incentives are intended for low-income earners to assist in the purchase of an e-bike.

# 23. Director's Report

Executive Director Guy Preston delivered the director's report, highlighting the release of the countywide draft Active Transportation Plan and noting that public comments are due March 25, 2022.

Director Preston also announced the retirement of RTC staff member Ginger Dykaar noting the many contributions made by Ms. Dykaar during her more than 10 years at the RTC.

Commissioner McPherson made a motion and Commissioner Alternate Schiffrin seconded the motion to approve a resolution to honor retiring senior transportation planner Ginger Dykaar. The motion passed unanimously with Commissioners Bertrand, Brown, Johnson, Caput, Koenig, McPherson, Petersen, Parker, Rotkin, and Commissioner Alternates Hurst, Schiffrin, and Quinn voting "aye."

Senior Transportation Planner Ginger Dykaar thanked the staff and Commission for all the opportunities and highlighted some of her accomplishments.

# 24. Caltrans report

Caltrans District 5 Deputy Director Scott Eades announced the release of the District 5 Active Transportation Plan, found at <a href="mailto:catplan.org">catplan.org</a>. In the City of Santa Cruz and County of Santa Cruz, the Main Beach Restrooms and the Green Valley Road Multi-Use Trail Improvement Project were among the projects chosen to receive funding.

Commissioners discussed: appreciation for Measure D voters for funding the Highway 17 Wildlife Crossing project which is currently underway, appreciation for the Highway 152 & Holohan Road improvement projects and the litter control and bicycle/pedestrian improvements in the Pajaro Valley; responsiveness of Caltrans on Highway 9 and Highway 17 projects.

In response to a commissioner's questions, Mr. Eades provided clarification on the relationship between the Active Transportation Plan, the unmet needs identified, and the projects intended to meet those needs; the trail rehabilitation project in South County; Clean California grants focused on beautification, trash removal, and education campaigns.

# 25. City of Santa Cruz Presentation

City Engineer for the City of Santa Cruz Nathan Nguyen delivered a presentation highlighting projects in collaboration with and funded by the RTC.

In response to questions from commissioners, Mr. Nguyen clarified that the Rail Trail Segment 7 Phase 2 project is expected to be completed in April 2023 and confirmed the bid release date had been delayed and is rescheduled.

Commissioners discussed: traffic impacts resulting from the Murray Street Bridge project coinciding with the Soquel Drive multimodal projects; congestion mitigation and coordination between partner agencies; consideration of contractor incentives for timely project delivery; plans to communicate traffic information to the residents in the surrounding communities.

Commissioner McPherson departed the meeting and Commissioner Alternate Virginia Johnson took his place.

Transportation Planner Amy Naranjo delivered the staff report and a presentation.

Commissioners discussed: how we are addressing public comments; flex lane study on major corridors (i.e. Soquel Drive); need for a workshop to better understand transportation funding, how it relates to long-range planning, and how the funding landscape has changed at the federal level; urgent need to cut carbon emissions from car-centric travel; Commission is committed to climate crisis response; various ways that transportation infrastructure facilitates and/or counteracts carbon emissions; feasibility of financing large scale transit infrastructure in Santa Cruz County over time; RTP is a living document that will continue to be updated as we move forward.

Deputy Director Luis Mendez and Senior Transportation Engineer Sarah Christensen responded to a commissioner's question regarding possible uses of the Measure D Highway 1 corridor investment program funding category. Mr. Mendez clarified that the final RTP posted to the website includes revisions based on comments received from Caltrans and updates to project costs based on the most recent information that staff could obtain.

Heather Adamson, Planning Director of the Association of Monterey Bay Area Governments (AMBAG), provided additional information about public comments received on the draft Environmental Impact Report (DEIR) and the timeline for the release of the final EIR.
