

# **Local Assistance Updates**

## **Buy America Changes**

- Build America Buy America Act (BABA) is part of the Infrastructure Investment and Jobs Act (IIJA) or Bipartisan Infrastructure Law (BIL)
- Required for the recipient of all federal-aid funds to ensure all iron, steel, manufactured products, and construction materials used on projects are produced in the United States.
- Applies to local agency projects that request an authorization (E-76) on or after November 10, 2022.
- HQ Local Assistance will release an Office Bulletin to summarize changes and update the Local Assistance Procedure Manuals (LAPM) Chapter 12 and forms.

### New IIJA Programs

- HQ is updating in the Local Assistance website with IIJA program information.
- New links have been added for the CRP and SS4A programs.
- District Local Assistance will have a IIJA Program specialist.
- Reach out to District Local Assistance if IIJA funds are granted.

#### Risk Assessment Program

- Local Public Agency (LPA) Risk Assessment Program (aka Certification) is a riskbased process whereby a state DOT certifies LPA's ability to administer the delivery of a fed-aid project with oversight from state as-needed.
- HQ is currently developing details of the program. Major components will be:
  - Mandatory Training
  - LPA Certification Risk Assessment (online application proposed)
  - o Risk-based Oversight and Monitoring (either Tier 1, 2, or 3)
  - o Re-certification (every 3 years)
- Currently, in beta stage with select agencies. Estimated to roll out to all agencies by 2024.

#### Caltrans 2022 Standard Plans and Standard Specifications

- Will be published on October 24, 2022
- Date for Local Agency to incorporate into project is TBD
