How It Works

Join the Go Santa Cruz County commuter network to get started.



Log Commute Trips

Track your walk, bike, carpool, transit, or telecommute trips.

Log more trips to increase odds of winning monthly giveaways.



Earn Points

Earn 10 points for every eligible trip logged.

Limit 2 trips per day.



Redeem Rewards

Get a \$10 virtual gift card when you redeem 250 points.

Limit \$100 per user per year.



One Ride at a Time

Promote METRO as the environmentally smart transportation choice for Santa Cruz County while supporting organizations making a difference in our community.

Donate \$10 for every 25 transit trips logged.















Following

Electric Bicycle Incentives

Electric bikes are becoming increasingly popular as a form of transportation, due to their environmental benefits and cost savings.



Existing Programs

Electric Bike Rebates



California Air Resources Board

\$1000 base incentive, +\$750 for cargo or adaptive bikes, +\$250 for people living below 225% FPL \$10M available statewide.

Coming Soon.



Monterey Bay Air Resources District

\$500 base & \$1000 income qualified rebates. 90 out of 116 rebates issued to low income applicants. FY23 funds claimed in 2 months. **Pending**.



Go Santa Cruz Downtown

\$400 base & \$800 incomequalified rebates. 90+ rebates issued. Limited to City of Santa Cruz and downtown employees.



E-BIKE Act of 2023

Electric bike tax credit bill reintroduced in Congress in 2023. Would cover up to 30% of the cost of a new e-bike, maximum \$1,500. **Pending**.

Considerations for a Countywide E-Bike Voucher Pilot



Funding Source

Apply for STBG/RSTP funds through RTC's consolidated funding program in Fall 2023

2 Eligibility Criteria

Align criteria with Statewide EBIP and encourage stacking the rebates where applicable to help reduce the price further.

3 Voucher Amounts

Establish a base incentive plus additional incentives for meeting other criteria

4 Community Feedback

Solicit and incorporate input to develop expanded pilot program



Staff Recommendations

Approve Resolution

Authorize the Executive Director to extend the contracts with Miller-Maxfield and Ecology Action through FY 23/24, as shown in Attachment 5.

Approve Budget amendment

Approve a fiscal year (FY) 2022/23 budget amendment for the Cruz511 program, as shown in Exhibit A of Attachment 5.

Provide Input on Countywide E-Bike Rebate program Pilot

Discuss possibility of providing electric and/or standard bicycle rebate vouchers for income qualified applicants, including potential funding sources.
