

Measure D Program UPDATE

- Passed by Voters November 2016
- County Receives Share of Neighborhood Streets Portion
- Current Yearly County Share Approx. \$3.8 Million
- County has used primarily for resurfacing of local roads
- Have put out a resurfacing project each year since 2018
- 43 miles resurfaced (2018-2023), averaging 7.2 miles/yr



This Project leveraged several funding sources (including, Measure D, Refuse Funds, STIP, RSTP, Interagency Partnerships, and Road Funds) to provide a total of 16 miles of resurfacing.

Alba Road, Jamison Creek Road, and Empire Grade are vital links between the communities of Bonny Doon and the San Lorenzo Valley and were heavily damaged in the 2020 CZU Complex Fire. This project paved nearly 9 miles of County roadways.



Waiting on availability of STIP funds




Storm Damage Sites

Santa Cruz County led the State in storm damage sites in both the historic 2017 & 2023 Storm Seasons.

These disasters have taken a heavy toll not just on our roads, but our local road funding sources as well.

Season	Damage Sites	Recovery Cost	Percent Complete
2017	220	\$120M	80%
2023	217	\$140M	40%


- 2017 & 2023 Storm Damage Repair Projects

- Signal Operational Improvements







County Road Statistics PCI Projection from 2018


- 2018 Average PCI was 48
- \$24M/yr to hold PCI 48
- With \$8M/Yr Funding, PCI was projected to drop to 33 by 2028
- Actual Budget \$5-\$6M/yr.
